The Sample item of the unsuccessful bidders will be returned on finalisation of the contract. The sample item of the successful bidder shall be retained and shall be adjusted against the total supply made by them.

4. Each bidder is required to submit an EMD of an amount of Rs.5000/- (Rupees Five thousand only) through Demand Draft/Bankers cheque or any other cashless mode in favour of "PAO, Cabinet Affairs, New Delhi." The EMD of the unsuccessful bidders will be returned after finalisation of the tender process. The EMD of the successful bidder shall be returned after the supply of the requisite items. Vendor has to supply the items in good condition at the chosen venue.

5 Cover containing the quotations should be sealed and super scribed "QUOTATION FOR SUPPLY OF HAND BAGS and sent/delivered either by post or by hand so as to reach the undersigned on or before **3.00 PM on Friday the** 17**th March, 2017**.

6 The bidder should quote the price and vat/taxes, if any, separately.

7 Successful bidder will be required to deliver items in the store of this Ministry or at any other place in Delhi as per the requirement within five days of the order placed to the supplier.

The bids will be opened on the same day i.e. 17<u>th March, 2017</u> <u>at 3.30 PM</u> in the Chamber of Deputy Secretary (Admn.), Ministry of Parliamentary Affairs, 92, Parliament House, New Delhi. Authorised representatives of the firms who wish to be present at the time of opening of the quotations may be permitted to do so subject to the submission of an identity proof and authorisation on the letter head of the firm.
