During the month of February, 2022, 20 Assurances were culled out from Lok Sabha proceedings and 26 Assurances were culled out from Rajya Sabha proceedings.

During the month of February , 2022, 112 Implementation Reports were laid in Lok Sabha and 49(01 Part) Implementation Reports were laid in Rajya Sabha.

Informal Consultative Committees were constituted for various Ministries/Departments of Government of India, first time in the year 1954 to provide opportunities to Members of Parliament to have some glimpse into the working of the Government.
