#### • Implementation of Assurances in Parliament

During the month, 05 Assurances were added at the instance of Committee on Government Assurances Lok Sabha while 02 Assurances were added at the instance of Committee on Government Assurances Rajya Sabha.

- b. #### • National e-Vidhan Application (NeVA)

During the month of September, 2023 the following activities were undertaken on NeVA front:

- 1. Inauguration of NeVA project in Gujarat- Hon'ble President of India, Smt. Draupadi Murmu inaugurated NeVA project for Digital Legislature in Gujarat Assembly in the presence of Shri Bhupendra Patel, Chief Minister, Gujarat and Shri Shankar Choudhary, Speaker, Gujarat Legislative Assembly on 13th Sept., 2023. The inauguration session was also attended by the Secretary, MoPA.
- 2. Visit by officials from CPMU NeVA to Gujarat Assembly- Officials from CPMU NeVA visited the Gujarat Legislative Assembly from 4th -7th September 2023 and 11th to 17<sup>th</sup> September, 2023 to provide training to the house officials before going live on NeVA platform. The team members were honoured by Hon. Speaker, Sh. Shankarbhai Chaudhary for their excellent work in making the Gujarat Assembly a digital assembly through the NeVA platform.
- 3. Visit by officials from CPMU NeVA to Meghalaya Assembly –3 officials from CPMU NeVA visited Meghalaya Assembly, Shillong from 15th to 22nd Sep., 2023 to provide training to the Assembly officials to enable them to successfully run their session on NeVA platform.

- **4. Visit by officials from CPMU NeVA to Punjab Assembly-** 4 officials from CPMU NeVA visited Punjab Assembly, Chandigarh from 21st Sep., 2023 to 22nd Sep., 2023 to attend the inauguration of NeVA project in Punjab Assembly. The Hon'ble Chief Minister of Punjab, Shri Bhagwant Mann, inaugurated #NeVA in the Punjab Legislative Assembly, initiating a new era for the state's digital legislature proceedings.
- 5. Visit by senior officials from Tripura Assembly to CPMU, NeVA- Additional Secretary, Ministry of Parliamentary Affairs had a meeting with Additional Secretary, Tripura Legislative Assembly in Delhi on 25th September, 2023 He had an appraisal of the status of implementation of NeVA project in the Assembly.
